- a) **10 Year Downtown Revitalization Strategy Engagement –** Phil Caldwell, Acting Manager Commercial Districts & Small Business, Economic Development Division, City of Hamilton.
- Provided an overview of Hamilton's 10-Year Downtown Revitalization Strategy, which includes the arena redevelopment and aims to address safety, infrastructure, and business growth.
- Engagement with community and stakeholder groups is already underway, including at the Hamilton Farmers' Market. This engagement will help shape a plan that will bring more people, investment, and activity to the core directly benefiting HFM vendors and visitors.
- Initial findings will be presented to Council on July 9 and a draft strategy is expected by December.

b) Market Manager Report – Bill Slowka

- The Market has purchased new stacking chairs and folding tables to better support our growing schedule of events.
- The Local Showcase is confirmed for June through August, with two new vendors joining in June. May was packed with successful events, including Sample Saturday, which featured 26 vendors and drew great feedback.
- We kicked off a children's lunchtime concert series, launched a new photography exhibit, and have more summer programming planned.
- HFM Kids Club is starting with fun activities designed to engage our youngest visitors.

c) Senior Program Manager Report – Adam Watson

- Lighting feasibility study assessing the lighting in the Market from both an energy efficiency and utility bill perspective, potential 70-73% electricity usage reduction.
- Starting a comprehensive HVAC and electrical assessment
- A follow up vendor survey has been sent out and closes June 13. The results of this will help inform the development of a new vendor attendance policy.
